**SNOWPLOWING NOTICE**

The commission discussed information that should be addressed in a newspaper notification of the Winter Parking and Snow Plowing Restrictions. Vehicles parked on the street or right-of-way that hinders snow removal will be towed away at the expense of the owner. It is unlawful to plow snow across or deposit snow on any road way or plow snow in a manner that obstructs the safety vision of a driver of a motor vehicle. Winter Parking; snow plowing & removal ordinance will be strictly enforced from October 15<sup>th</sup> to April 15<sup>th</sup>.

**WEBSITE REVISIONS**

The Manager discussed how we plan to revise the Village website and asked the committee to think of questions or items of interest that should be included concerning the Planning Commission.
