TERM OF OFFICE

VILLAGE HOUSING COMMISSION:

This commission shall consist of five members who shall be appointed by the Village President. The term of office shall be five (5) years.

RECREATION COMMISSION:

This commission shall consist of seven members, four members shall be appointed by the Village President from among the electors of the Village. The fifth member shall be a representative from the Hockey Association or Figure Skating Club. The sixth member of the commission shall be appointed from among the Village Trustees and the seventh member shall be the Village Manager. These members shall serve three (3) year terms.

PLANNING COMMISSION:

This commission shall consist of five members, one shall be appointed from among the Village Trustees. One appointed member may be a member of the Zoning Board of Adjustment or Appeals. This commission is not restricted to electors of the Village. These members shall serve three (3) year terms.

MARINA COMMISSION:

This commission shall consist of seven members, appointed by the Village President. Four of the seven members shall be chosen from among the electors of the Village, the fifth member shall be appointed from among the electors of Ontonagon County, the sixth member shall be appointed from among the Village Trustees and the seventh member shall be the Village Manager. These members shall serve three (3) year terms.
