RESOLUTION NO. 2021 – 07**

**A RESOLUTION TO ESTABLISH A UNIFORM START DATE FOR THE TERMS OF MEMBERS OF COMMISSIONS AND AUTHORITIES**

At an electronic meeting of the Village Council of the Village of Ontonagon, held on the 22nd day of February, 2021, in the offices at 315 Quartz Street, Ontonagon, Michigan, the following resolution was offered by Trustee Hamm and supported by Trustee Hopper:

**RECITALS**

WHEREAS, the Village of Ontonagon operates under the General Law Village Act of 1895 PA3, as amended, and

WHEREAS, within the State of Michigan, the legislative authority of villages is vested in village councils and the village councils make all policy decisions, including review, revision, and final approval of village business, and

WHEREAS, the Village Council of Trustees established, re-established, and confirmed standing Committees, Commissions, Authorities and Liaisons by Resolution 2019 – 03 and Attachment A to Resolution 2019 – 03, and

WHEREAS, the Village Council of Trustees established terms of office for certain Commissions and Authorities by Resolution 2020-02, and

WHEREAS, the start dates for the terms for members of Commissions and Authorities currently begin at different times of the year, and

WHEREAS, the Village Council of Trustees desires to establish uniform start dates for terms of members of all Commissions and Authorities,

NOW, THEREFORE, BE IT RESOLVED, the Village of Ontonagon Council of Trustees declares the end date for the terms of members of Commissions and Authorities under the control of the Village to be September 30 of the year that the rotating terms expire and that the new term shall commence on October 1 of that same year, unless otherwise required by statute or ordinance.
